Annexure – 1

GENERAL TERMS AND CONDITIONS

Sub:-Notice Inviting Expression of Interest for "Empanelment of Bus services Providers"

- 1. **Parties:** the parties to the Contract will be the contractor providing the Bus services and the Institute availing the services.
- 2. **Addresses:** For all purposes of the contract including arbitration thereunder, the address of the contractor mentioned in the Expression of Interest shall be final unless the contractor notifies a change of address by a separate letter. The contractor shall be solely responsible for the consequences of any omission or error to notify change of address in the aforesaid manner.
- 3. **Earnest Money Deposit:** Earnest Money Deposit (EMD) of Rs. 10000/- (Rupees Ten thousand only) in the name of "Indian Institute of Management Kashipur" payable at Kashipur in the form of demand draft of any nationalized bank must be deposited by bidder, along with the Technical Bid. Without EMD amount the bid will not be considered and will be liable to be rejected.
- 4. **Preparation and Submission of Expression of Interest:** The Expression of Interest should be submitted in two parts namely, Technical Bid (in form given in Annexure I, II & III) and Commercial Bid (in form given in Annexure IV) and each should be kept in a separate cover duly marking as Technical Bid and Financial Bid. **Both the envelope should be kept in a larger envelope duly super scribed with "EOI for Empanelment of service providers for Bus services."**
- 5. **Signing of Expression of Interest:** The individual signing the expression of Interest or other documents connected with contract must specify whether he signs as: (a) A "sole proprietor" of the concern or constituted attorney of such sole proprietor. (b)A partner of the firm, if it be a partnership firm, in which case be must have authority to execute the document.
- 6. **Validity of the Bids:** the bids shall be valid for a period of 90 days from the date of opening of the Expression of Interest.
- 7. **Opening of Expression of Interest:** Firms must be present at the time of opening of the Expression of Interest either on his own or through authorized representative to be eligible for further consideration. The representative attending the opening of the Expression of Interest on behalf of the firm should bring with him a letter of authority from the firm and proof of identification.
 - a. The bidders fulfilling technical specifications as given in Annexure-I, II & III will be declared technically qualified.
 - b. Evaluation of bids: On the basis of rates quoted by different bidders the committee will finalize rates for each segment of commercial bid & the same will be offered to all interested technically fit bidders.
 - c. On the basis of acceptance given by bidders they will be empaneled for the said services.
- 8. Contract Period: The contract period will commence from the date of agreement. The contract will be for a period of two years further extendable up to one year, subject to satisfactory performance and discretion of competent authority.
- 9. Right of Acceptance: The Institute reserves the right to accept or reject any Expression of Interest including of those firms who fail to comply with the instructions without assigning any reason whatsoever, and does not bind itself to accept the lowest or any specific Expression of Interest. The decision of the Institute in this regard shall be final and binding.
- 10. Communication of Acceptance: Successful parties will be informed of the acceptance of their offer.
- 11. **Penalty:** In case of breach of any conditions of the contract as losses caused including excess cost due to hiring of Bus from the market in the event of Contractor failing to provide requisitioned Bus or not providing Bus, the Institute shall make deductions at double the rate of hiring rate on prorate from the pending / upcoming bills of the contractor. In other cases following will be the criteria for imposing penalty.

Note: - Repeated default will invite double rates of penalty.

- 12. Breach of Terms and Conditions: In case of breach of any of the terms and conditions mentioned above, the Chief Administrative Officer will have the right to cancel the work order without assigning any reason thereof, and nothing will be payable by this Institute in that event and the security deposit will be forfeited.
- 13. Sub-letting of Work: The firm shall not assign or sublet the work or any part of it to any other person or party.
- 14. In case of accident, any compensation claims arising out of such accident shall be borne/made by the contractor in accordance, with the law which is in force to each or every one of the effected person or their legal heirs depending upon the merits of each individual case. He would also indemnify the Institute for any loss, damage of property or life arising out of negligence of driver or poor maintenance of vehicle. The driver should always remain with the vehicle during entire period of duty. In case of any urgency, the driver may seek permission of the user / Institute.
- 15. **Performance Security:** The firm whose tender is accepted shall deposit Performance Security for an amount of Rs.10000.00 (Rupees Ten Thousand) in any of the following forms within 30 days from the date of award of the contract. Performance Security may be furnished in the form of Demand Draft or Fixed Deposit Receipt or Bank Guarantee in favour of 'Indian Institute of Management Kashipur' from a commercial bank. Performance Security will remain valid for a period of sixty days beyond the date of completion of all contractual obligations. No interest will be payable on this amount. In case of breach of contract by the contractor, the Performance Security shall be forfeited by the Indian Institute of Management Kashipur and the firm shall be blacklisted in addition to the termination of the contract.

16. **Terms of payment:**

- 16.1 No payment shall be made in advance.
- 16.2 All payments shall be made by the NEFT/cheque only.
- 16.3 Institute shall be at liberty to withhold any of the payment in full or part, subject to recovery of penalties mentioned in preceding clauses.
- 16.4 In case higher model Bus provided in place of called Bus then the Institute will pay for vehicle called and not for vehicle provided.
- 16.5 The terms "payment" mentioned in this paragraph includes all types of payments due to the contractor arising on account of this contract excluding Security Deposit governed by the separate clauses of the contract.
- 17. The requirement of bus / buses will be intimated to the service provider by email/ telephone, two days advance for local use and four days in advance for outstation trips.
- 18. The meter reading would be permitted from local garage to garage basis (The garage should be in locality of Kashipur only). Only one item from local charges i.e. extra kilometre or extra hour rate will be payable (whichever is higher). Night Charges will start from after 11:00 PM and before 5:00 AM.
- 19. GST as applicable shall be payable extra. Toll tax, parking charges, state/border entry/exit tax of visiting/crossing states for outstation trips shall be reimbursed by the Institute against the production of documentary evidences.
- 20. The maintenance cost, Charges of Petrol/Diesel, road tax, passenger tax, permit fee, Challans, wages of the driver/helper, the overtime of driver etc., will be the responsibility of the contractor for which no payment shall be made by IIM Kashipur.

Annexure – II ELIGIBILITY CRITERIA PARAMETER AND TECHNICAL SPECIFICATIONS

- The intending party/ firm must own minimum 3 number of commercial vehicles either registered on
 its/proprietor's name or must have a contractual arrangement with the actual vehicle owners for
 providing the services. The list of vehicles along with photocopies of registration certificates and
 experience certificate should be attached with the technical bid.
- 2. Bus to be provided by the Contractor should be in perfectly sound running condition i.e. suitable for use by the personnel of Institute.
- 3. Only such Agency / Firm may apply whose Bus have been duly authorized by the concerned RTO (i.e. the vehicles should be registered as Bus) for use as public transport and who have telephone and mobile connections available at their Premises/Garage/Stands Office/in-person from where such Bus are to be operated and can be requisitioned by the Institute.
- 4. The firm should abide by all labour laws as applicable from time to time.
- 5. (i) The firm should ensure that the drivers employed hold valid driving license, are in uniform, well behaved, reasonably educated, conversant with traffic rules/regulations and city roads/routes as well as with the security instructions.
 - (ii) The firm should ensure that none of the driver has any criminal/legal case pending against him in any police station or court of law.
 - (iii) Each driver employed by the firm must have a cell-phone duly activated.
 - (iv) No mileage will be allowed for lunch/tea etc. to the driver. The drivers are not allowed take hired vehicles for their personal lunch and / or tea during duty hours.
 - (v) The Contractor must ensure that driver is not under the influence of alcohol or other intoxicants while performing their duties for the Institute. In no case, the driver should be allowed to smoke while driving the vehicles. No other person except the driver shall be permitted in the vehicle while transporting the personnel / guests of the Institute.
 - (vi) The service provider and the drivers should ensure that each vehicle is neat and clean as well as operationally fit (i.e. with no known fault) and sufficient fuel when on duty.
 - (vii) While the Institute has a periodical requirement for hiring of Bus, it shall have the right not to utilize the service at all at any time for any period without giving any notice/assigning any reason. The Institute reserves the right to hire Bus from any other provider of such services even during the period of the contract.
 - (viii) Revision of rates will not be entertained during the period of contract in normal course. However, if fuel price rise by 15% then the rates will increase by 5% (rounded off to next 50 paisa) not exceeding 5% for each block of 15% price rise. In case the fuel prices decrease by 15% the same benefit will be passed on to the institute. Every 15% increase or decrease in fuel prices will lead to a corresponding 5% increase or decrease in quoted rates. Rate of fuel as on date of agreement will be taken as base price.
 - (ix) "Full Day" would imply a run of the Bus up to 80 kilometer and/or 10 hours duration.
 - (x) Rates once finalized will be valid for the period of contract including renewal, if any.
 - (xi) It is the responsibility of the service provider to have all necessary clearances and certificates required to carry out the services of public transportation.
 - (xii) All legal disputes shall be subject to the Jurisdiction of Kashipur.
 - (xiii) Any person who is in Government service or an employee of this IIM Kashipur should not be made partners to the contract by the contractor directly or indirectly in any manner whatsoever.
 - (xiv) The Institute reserves the right to terminate the contract by giving 30 days' notice without assigning any reason whatsoever.
